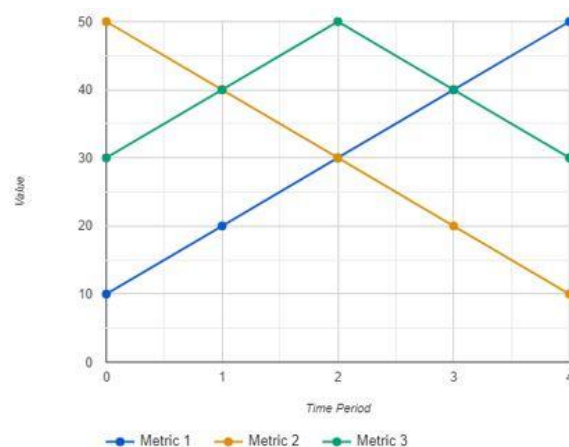

After Transformation (data accuracy and completeness): Flawless and timely submission.

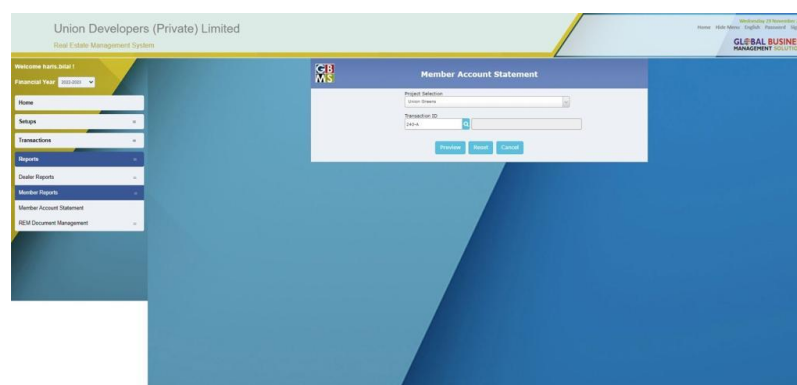

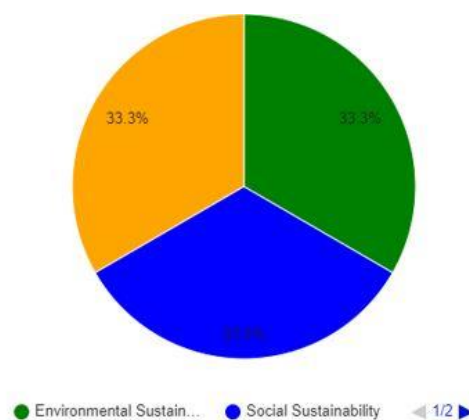
